Types of Damages under Section 73 of the Indian Contract ...

The Indian Contract Act, 1872 was enacted on 25th April, 1872 [Act 9 of 1872] and subsequently came into force on the first day of September 1872. The essence of the India Contract Act has been modelled on that of the English Common Law. The extent of modifications made in the Act as per the Indian conditions and its adaptability to the Indian economy is an important area of research.

History of the Indian Contract Act 1872

The agreement is void, as it renders the transaction, in effect, a purchase by the defaulter and would so defeat the object of the law. (i) A's estate is sold for arrears of revenue under the provisions of an Act of the Legislature, by which the defaulter is prohibited from purchasing the estate.

Section 23 in The Indian Contract Act, 1872

This Act may be called the Indian Contract Act, 1872. Extent, Commencement. -It extends to the whole of India 1 [except the State of Jammu and Kashmir]; and it shall come into force on the first day of September 1872.
